Season Pass Savings: You will receive a 50% discount off the Energy Charge during the Season Pass discount period. Season Pass discount period is from December 1st 12:00 a.m. through February 28th 11:59 p.m. and June 1st 12:00 a.m. through August 31st 11:59 p.m.

Usage for the Season Pass discount period is determined from interval data from your advanced meter (Interval Data) and is also provided by the TDU.
