Your average price per kWh each month is determined using the formula below based on your Monthly Billed kWh Usage. TDU Delivery Charges Per Month and TDU Delivery Charges Per kWh will be passed through to you as billed from the Transmission and Distribution Utility ("TDU").

Price per kWh = Base Charge + TDU Delivery Charges per month + (Monthly Billed kWh Usage multiplied by the (Energy Charge + TDU Delivery Charges per kWh)) / Monthly Billed kWh Usage

Season Pass Savings: You will receive a 50% discount off the Energy Charge during the Season Pass discount period. Season Pass discount period is from December 1st 12:00 a.m. through February 28th 11:59 p.m. and June 1st 12:00 a.m. through August 31st 11:59 p.m.

The total kilowatt-hour usage shown on your monthly invoice (Billed Usage) is provided by the TDU. Usage for the Season Pass discount period is determined from interval data from your advanced meter (Interval Data) and is also provided by the TDU. If the Billed Usage and Interval Data do not match: 1) any missing intervals in the Interval Data will first be determined using market information for your usage profile, then these intervals will be proportionately adjusted so the sum of all intervals equal the Billed Usage provided by the TDU; or 2) if there is no missing interval information, each interval of the Interval Data will be proportionately adjusted so the sum of all intervals equal the Billed Usage provided by the TDU.
